 - Open recruitment via expressions of interest preferred with some targeting, schedule release of Chair vacancy last week in October.
- Remuneration policy AGREED possible time commitment per month is 2 hours and a remuneration policy for members attending outside of their paid roles will commence 1st April 2021.
